

# TECHNICAL SPECIFICATIONS FOR THE CONTRACTING OF GPS TRACKING DEVICES

# 1. PURPOSE OF THE CONTRACT

The purpose of the contract is The FIIAPP F.S.P. requires the provision of GPS tracker devices and associated software to enable technical surveillance of vehicles.

It is the object of the contract to identify an adequate supplier of ICT and Mobile Data systems that can provide GPS tracker devices, associated software, provision of adequate training and written Standard Operating Procedure and deliver to our offices in Georgia, Ukraine, Tanzania and Kyrgyzstan

# 2. DESCRIPTION OF THE SERVICES TO BE PROVIDED

The services to be provided will be a first delivery of 5 devices in Tbilisi (Georgia) and training of basic use in the same country.

The operations, object of this contract, will be the following:

#### **Basic requirements:**

- Covert tracking devices for cross-border operations, able to be deployed quickly, with short, medium and long-term capability, targeting vehicles (car and lorry)
- Rechargeable battery power supply
- Use of mobile/cellular network (2G, 3G, 4G), and satcom, with secure communications.
- Ability to log movements and to provide live tracking.
- Internal storage of data
- Instructions, command and control to be actionable remotely
- Appropriate software to enable the use of Windows-based mapping applications for geolocation.
- Written Standard Operating Procedures, covering the use and oversight of the equipment.
- Translation of Standard Operating Procedures into the local languages.
- Door to Door delivery service; supplier takes care of all procedures regarding customs, taxes, etc
- Provision of adequate training in the operation equipment: Basic



use/ functionality.

Performance of the contract will comply with the conditions detailed in the Particular Administrative Conditions and the Technical Specifications, which are contractual in nature, wherefore they must be signed by the successful bidder in witness whereof, in the same act of formally executing the contract.

# 3. CONDITIONS TO BE COMPLIED WITH WHEN PROVIDING THE SUPPLY

#### 1. Bids:

Interested parties will submit bids according to the conditions set forth in the administrative specifications, in the proper manner and form, for supply of GPS tracker devices.

# 2. Specifications:

The tenderer shall assume all costs arising from the delivery of the products in Tbilisi (Georgia) (transport, taxes, customs, tariffs etc.)

# 4. ADDITIONAL SERVICES

Additional services are considered those that may be derived from the free provision or allocation, by the tenderer, of services pertaining to the purpose of the contracting, as long as they can be financially assessed and are related to and directly useful for developing the purpose of the contract.

# 5. DELIVERY AND BILLING

Products will be delivered in Tbilisi (Georgia), as it is specified in point 3, section 2 of these specifications. The successful company undertakes to comply with the agreed delivery period, for each job, therefore assuming the liability in the event of a delay.

Payment will be made by bank transfer within a period of no more than thirty days as from the date when an invoice is submitted.
