1. OBJETO

Coaching/mentoring service to improve the project and team management skills of the EU-ACT Team Leader.

2. DESCRIPCIÓN DE LOS SERVICIOS A REALIZAR

Description of the service to be provided:

Initially, a diagnosis phase will be developed to identify the main challenges and to establish an initial work plan with the Team Leader (TL). This initial phase will include discussions with the Team Leader as well as the inputs of FIIAPP's Directors, Project Management in FIIAPP HQ and the Regional Coordinators of the project.

Products expected:

- A report with conclusions and recommendations.
- A work plan for the second intensive phase of the coaching.

In this second phase, the coach will work with the TL (in Ukraine and during his international travels) for 3 weeks. It is expected that he/she works intensively with the TL in order to:

- Identify the TL's main leadership and management challenges.
 - Work specifically in the acquisition, improvement and strengthening of:
 - Planning and reporting skills.
 - Team management and team leadership skills, including:
 - motivating and coaching team members.
 - creating an empowering, trustworthy and motivating work climate.
 - adapting management style to the cultural and gender diversity of the team.

- being able to set goals and make sure all team members are aligned around them.
- Using effective delegate techniques.
- Communication skills, particularly with regards to the team and with external collaborators.

Products expected after this period:

- Evaluation report with conclusions and recommendations.
- Set up a series of short, medium and long-term objectives that can be followed up and evaluated by FIIAPP.
- A plan of follow up (remote) sessions for a 2-months period.

In the third phase, after the 2 month follow-up period, the coach will:

- Prepare a final conclusions and recommendations report.
- Have a conclusions session with the TL.
- Have a conclusions session with FIIAPP and support the organization in the evaluation of the TL's progress.
- Final joint evaluation and conclusions session with TL and FIIAPP.

3. DURACIÓN

The contract will last 4 months, from the date of its signature.

The contract depends on the final decision by the funder. Therefore, the current offer is not a contractual commitment.
